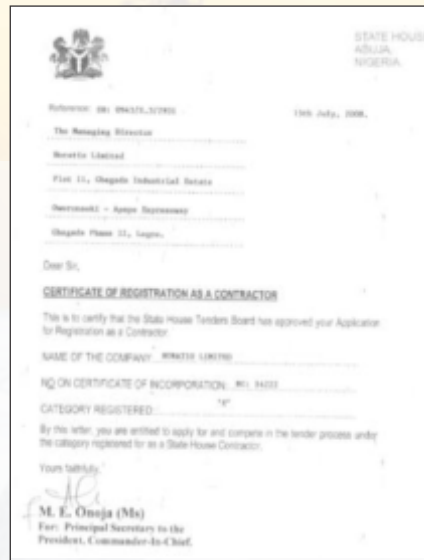

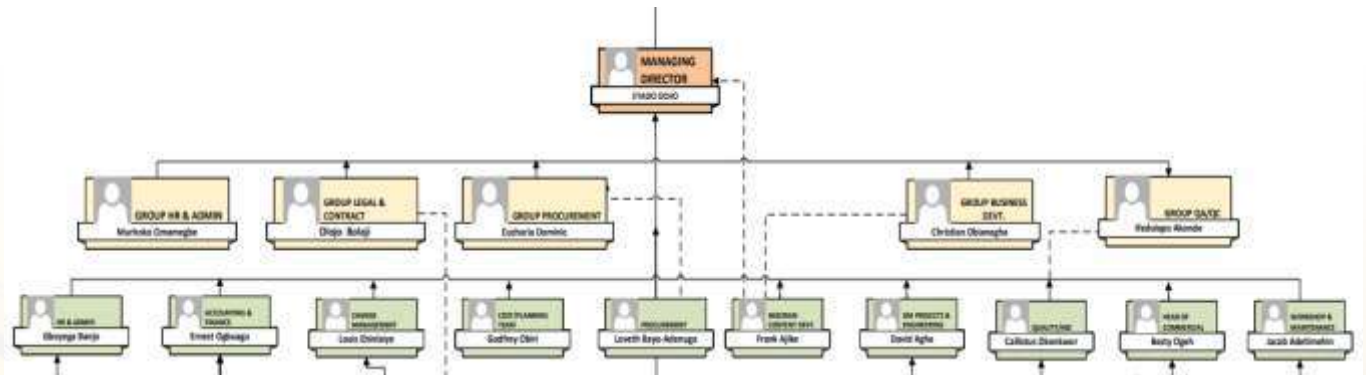

THE DUCHESS INTERNATIONAL HOSPITAL AT IKEJA FOR THE REDDINGTON HOSPITAL GROUP

The Duchess International Hospital, Ikeja, Lagos, a subsidiary of The Reddington Hospital Group is an ultra-modern, state-of-the-art fully ensuite 100-bed hospital facility delivering advanced multi-specialty healthcare in the Heart of the Lagos mainland. Horatio Limited, the 2nd bidder who lost by a slim margin in the tender stage was however engaged to execute on the works after the 1st bidder abandoned the project at the carcass stage.
